GREEN LAKE AREA COMMUNITY GARDEN RULES AND REGULATIONS

1. Application forms must be submitted by May 1, 2011. Lots will be available on a first come basis.
2. Garden plots are restricted to annual vegetables, herbs and flowers. A list of prohibited plants that are fast growing, vining or aggressive reproducers will be provided to gardeners.
3. Trees and tall shrubs are prohibited because of potential adverse effect on neighboring plots. Small shrubs may be planted only with prior approval from the Board of Directors. The only exception to this rule is roses, which must be removed at the end of the growing season.
4. The Green Lake Area Community Garden is committed to organic gardening practices. The use of fertilizers and pest/disease control measures not consistent with organic gardening standards is prohibited.
5. "Highrise" structures, walls, or any construction or assemblage of materials that encloses a plot or intrudes on another's is not permitted. Only one side of a garden plot can have vertical trellis-like, open, airy structures for supporting climbing vegetables, vines or flowers. Poles, stakes, cages and other supports that are used for plants are allowed.
6. Gardeners are responsible for the maintenance and upkeep of their garden plots. Watering, weeding, harvesting and other garden maintenance are all the responsibility of the gardener. Gardeners may arrange for other gardeners to water their plots.
7. Plots that in the opinion of the Board of Directors are being neglected will be cited. Gardeners will be given 10 days to address the problem or risk forfeiture of their plot.
8. Gardeners are responsible for weeding walkways bordering their plots and keeping walkways clear of debris, pots, etc. Plants cannot extend onto walkways and should be pruned, tied back or moved – especially if they are thorny. Bloch's Farm will provide pathway mulch free of charge.
9. Hoses and a limited selection of tools will be provided. Gardeners are encouraged to provide their own tools and can store them in the gardening shed. All tools and hoses must be cleaned and stored following gardening sessions. Please take special care not to damage someone else's plants when pulling a hose to your plot.
10. The garden will have a composting site for compostable materials generated within the garden. Large branches and stems and all thorny branches are prohibited from the compost site.
11. The garden is an all-volunteer effort. Gardeners are encouraged to volunteer some time toward the upkeep of the garden, especially cleanup periods at the start and end of the growing season.
12. Visitors are welcome but must be accompanied by a garden member. Because the garden site, Bloch's Farm, is private property, wandering beyond the garden site is strictly prohibited and is considered trespass. Pets are not allowed in the garden.
13. Restroom facilities on the farm are not available to garden users and visitors.
14. Bloch's Farm and the Green Lake Area Community Garden are not responsible for accidents and injury. **BY SIGNING THE ANNUAL GARDEN PLOT AGREEMENT, GARDENERS AND GUESTS AGREE TO HOLD HARMLESS THE GREEN LAKE AREA COMMUNITY GARDEN ORGANIZATION, MEMBERS OF THE GLACG BOARD OF DIRECTORS, AND BLOCH'S FARM FOR ANY LIABILITY, DAMAGE, LOSS OR CLAIM THAT OCCURS IN CONNECTION WITH USE OF THE GARDEN BY ANY GARDENER OR GUEST.**
